## GENERAL TERMS:

1. Semen will be collected and shipped on SDP Buffalo Ranch's breeding days only. In the event of limited supply, SDP Buffalo Ranch reserves the right to fly semen counter-to-counter on any given collection day at the mare owner's expense. I also understand that, due to the number of mares being bred to the given stallion, there is a possibility that on some collection days, SDP Buffalo Ranch will not be able to ship semen. Customer mares will always take precedence over mares owned by SDP Buffalo Ranch, but customer mares bred on-site take precedence over semen shipments.
2. **SEMEN WILL NOT BE SHIPPED NOR MARE BRED, UNTIL THE FEES AND SHIPPING ARE PAID IN FULL AND A SIGNED CONTRACT AND COPY OF MARE'S REGISTRATION PAPERS ARE ON FILE AT SDP BUFFALO RANCH. PAYMENT IS DUE AT THE TIME OF CONTRACT RETURN.**
3. Semen orders must be placed by 8AM CST on the day of collection.
4. DO NOT ORDER SEMEN VIA EMAIL, TEXTING OR ANSWERING MACHINE. YOU MUST TALK TO SDP BUFFALO RANCH PERSONALLY TO ORDER SEMEN.
5. SDP Buffalo Ranch agrees to ship semen to my mare up to and including July 15<sup>th</sup>, after that date it will be on a case-by-case basis. MOST STALLIONS ARE COLLECTED YEAR-ROUND, BUT THAT IS THE CONTRACTED DATE FOR END OF SEASON. I further agree to give my veterinarian or SDP Buffalo Ranch ample opportunity to settle her (having bred her through at least three heat periods). If however, for any reason she does not settle, I will hold SDP Buffalo Ranch harmless.
6. *Mare Owner shall hold SDP Buffalo Ranch, its agents, employees, veterinarians, and affiliates harmless for any accident, injury, illness, theft, or death suffered by the mare and/or foal, or any other cause of action whatsoever, whether occurring on or off the premises or in connection with shipped semen. Mare Owner understands that breeding, shipping, boarding, and handling horses involve inherent risks, and agrees to assume all such risks. In the event of injury, sickness, or death to the mare and/or foal, Mare Owner shall look solely to his/her own insurance for compensation. SDP Buffalo Ranch shall not be liable for any special, incidental, or consequential damages arising out of or related to this contract.*
7. It is further agreed that should the above named stallion die or become unfit for service and there is not any frozen semen available for use, or if my mare should die or become unfit to breed, then this contract shall become null and void, and any money paid as part of this service (except Chute Fee and shipping expense) shall be applied to another stallion standing at SDP Buffalo Ranch and shall be deemed a credit and I will be entitled to a rebreed or substitution the following year.
8. I agree to breed the mare specified on the breeding contract. If a mare change/substitution is needed, the first substitution will be free of charge. Each additional substitution will have a \$150 charge unless extenuating circumstances apply. **A fine of \$1,000 will be issued for inseminating any other mare without notifying SDP Buffalo Ranch of the change first.**
9. I agree to notify SDP Buffalo Ranch of the pregnancy status of my mare as soon as she is checked for pregnancy, regardless if mare is pregnant or open. A fee of \$150 will be issued for failure to notify SDP Buffalo Ranch of the mares pregnancy status by September 1<sup>st</sup>, the Breeders Certificate can not be generated nor will it be distributed until fee is paid if you fail to report.
10. I am guaranteed a live foal at the time of the signing of this contract and that if my foal does not stand and suck, I will be entitled subsequent return in season to the same mare (unless mutually agreed) until a healthy foal is achieved. **THIS GUARANTEE WILL APPLY ONLY IF I NOTIFY SDP BUFFALO RANCH WITHIN ONE (1) WEEK FROM DEATH; THIS NOTICE MUST BE ACCOMPANIED BY A STATEMENT FROM A LICENSED VETERINARIAN.** There shall be no liability upon SDP Buffalo Ranch on account of said guarantee except to grant me a free season for 1 mare until a successful healthy live foal is achieved. Said free season shall refer to the Stud Fees only. The Chute Fee, Breeders Invitational Fee (if applicable), mare cycle fee (if applicable), and shipping expenses will be charged as usual. There is no expiration for this live foal guarantee. Rebreds will be granted until a foal is produced.
11. In the event it becomes necessary for SDP Buffalo Ranch to enforce the terms of this contract, including but not limited to the collection of any sums due including expenses incurred by you, the Mare Owner – you agree to pay all expenses incurred by SDP Buffalo Ranch, including reasonable attorney's fees, court costs and potential collection fees.
12. I agree not to assign or transfer this contract without prior consent of SDP Buffalo Ranch.

- If a stallion is still showing and it conflicts with our set collection days, fresh cooled semen will NOT be available. However, frozen semen will be an option to send, if available. You will receive two (2) breeding doses with each shipment of frozen semen. Shipping fees are the obligation of the mare owner.
- A mandatory \$125 fee for the Breeders Invitational will be added if the stallion is nominated to the Breeders Invitational.**
- CHUTE FEE (\$675) IS NON-REFUNDABLE.**
- SMS Marketing Consent: By signing below, I agree to receive SMS text messages from SDP Buffalo Ranch, including updates, reminders, and promotional offers related to breeding services, incentive programs, and ranch news. Message frequency may vary. Message and data rates may apply. Reply **STOP** to cancel or **HELP** for help.
- This agreement is made within the governing of Texas Law, and shall be performable within Tarrant County, Texas.

## SHIPPING TERMS:

- The shipping container is the property of SDP Buffalo Ranch and does not require a deposit. However, SDP Buffalo Ranch requests that all containers be returned within 3 days. If the container is not returned it will be charged to the undersigned's account.
- SDP Buffalo Ranch reserves the right to approve all shipping locations. SDP will make every attempt to get semen to my mare in good condition; however, will make no guarantees or warranties that the semen will be in good condition upon arrival as shipping couriers are beyond SDP Buffalo Ranch's control.
- The Frozen shipping container is the property of SDP Buffalo Ranch and is valued at \$2,500. If the container is not returned within 3 business days, the card will be charged accordingly. SDP Buffalo Ranch does require a 48-hour notice to prepare the tank for shipping. There is a \$275 processing fee on all frozen semen shipments, which is included in the chute fee.
- All International Health Certificates (\$250) will be at the mare owner's expense.
- An additional \$225 fee will be applied to the customer's account if counter to counter is requested on the first shipment.
- Any additional shipments must be paid in full before semen will be shipped. And will be provided at your option per service of:

## ICSI & EMBRYO TRANSFERS:

This contract provides for one (1) Breeder's Certificate. If multiple embryos are produced, it will be the responsibility of the Mare Owner to notify SDP of the number of embryos produced. If Mare Owner desires to do a frozen embryo, it will solely be their responsibility to pay all fees associated. It is also the Mare Owner's responsibility to notify SDP when the frozen embryo is utilized. The stud fee of the year the frozen embryo is transferred *plus an Office Fee of \$300 and \$300 for resulting foal to go into the SDP Breeders Bonus Incentive* is due for every live foal produced.
